## Country Aspects

### 1. PHYSICAL ASPECTS

#### 1.1. WATER RESOURCES

##### 1.1.1. WATER RESOURCES

The Meghna River flows southwest, draining eastern Bangladesh and the hills of Assam, Tripura and Meghalay in India to join the Padma river at Chandpur. The Meghna then flows south for 160km and discharges into the Bay of Bengal.

The combined discharge of the three main rivers is among the highest in the world. Peak discharges are of the order of 100,000m<sup>3</sup>/s in the Brahmaputra, 75,000m<sup>3</sup>/s in the Ganges, 20,000m<sup>3</sup>/s in the upper Meghna and 160,000m<sup>3</sup>/s in the lower Meghna.

There are 230 rivers criss-crossing the country, most of which are either tributaries or distributaries to the GBM river systems. The total length of the river courses is approximately 24,000km and the total catchment area of the GBM is about 1.75 million km<sup>2</sup>, of which only 7 per cent lies within Bangladesh. There are 57 trans-boundary rivers in the country, of which 54 are shared with India and the remaining 3 originate in Myanmar.

On average, almost 1,106km<sup>3</sup> of water crosses the borders of Bangladesh annually, of which 85 per cent is between June and October. Around 54 per cent (599km<sup>3</sup>) is contributed by the Brahmaputra, 31 per cent (344km<sup>3</sup>) by the Ganges and nearly 15 per cent (163km<sup>3</sup>) by the tributaries of the Meghna and other minor rivers.

Because of the great disparity between the monsoon floods and the low flow during the dry season, the manageable surface water resources are considered as 80 per cent of the dependable flow in March. Surface water resources are used extensively for dry season irrigation, mainly for Boro rice using low-lift pumps (LLPs) and traditional devices.

The availability of groundwater resources in Bangladesh is determined by the properties of the groundwater storage reservoir and the volume of annual recharge. Key factors that determine groundwater availability include the capacity of the country's aquifers to store water and the extent of economic withdrawal of groundwater for irrigation, domestic and industrial needs. The sources of recharge are rainfall, flooding, and stream flow in rivers. The quaternary alluvium of Bangladesh constitutes a huge aquifer with reasonably good transmission and storage properties. Heavy rainfall and inundation during the monsoon help the aquifers to be substantially recharged annually.

A regional groundwater recharge assessment was undertaken in 1987 by Master Plan Organization (MPO) under the National Water Plan (NWP) of the Ministry of Water Resources. MPO updated the groundwater resources assessment during the NWP Phase-II in 1991, and the average annual available groundwater recharge for the country was estimated at 21km<sup>3</sup>.

The internal renewable water resources are estimated at 105km<sup>3</sup> per year. The overlap being considered negligible, this includes 84km<sup>3</sup> of surface water produced internally as stream flows from rainfall and about 21km<sup>3</sup> of groundwater resources produced within the country. Part of the groundwater comes from the infiltration of surface water with an external origin. Since annual cross-border river flows and entering groundwater are estimated to be 1,105.64km<sup>3</sup>, the total renewable water resources are estimated at 1,210.64 km<sup>3</sup>.

In 2007 there was only one multi-purpose dam, located at Kaptai in Rangamati Hill district. The total capacity of this dam is 20.3km<sup>3</sup>. In addition, there are three barrages constructed across the Teesta, Tangon and Manu rivers, which are used as diversion structures for irrigation purposes only.

In 1995, the installed capacity of all the country's power plants was about 2,907MW, of which about 230MW was hydroelectric.

##### 1.1.2. WATER USE

In 2008, the total water withdrawal was estimated at about 35.87 km<sup>3</sup>, of which about 31.50km<sup>3</sup> (88 per cent) was for agriculture, 3.60km<sup>3</sup> (10 per cent) for municipalities and 0.77km<sup>3</sup> (2 per cent) for industries.

Approximately 28.48km<sup>3</sup>, or 79 per cent of the total water withdrawal, comes from groundwater and 7.39km<sup>3</sup>, or 21 per cent, from surface water.

Only about 15km<sup>3</sup> annually, or about one per cent of total water resources, is withdrawn for human use. Of the total withdrawal, 86 per cent is for agriculture, 12 per cent for domestic water supply and 2 per cent for industry. Out of the total consumptive use of water (withdrawals minus return flows), 73 per cent is used for agricultural purposes and 20 per cent for evaporation in forests, water bodies, charland, and urban and rural environments, leaving 7 per cent for water supply and sanitation. Although population growth has slowed to less than two per cent per year, it is predicted that Bangladesh's total population will increase from 129 million people in 2000 to 181 million by 2025 and 224 million by 2050, accompanied by an increased demand for water.

#### 1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

Many people are landless and forced to live on and cultivate flood-prone land. Other major environmental problems include: waterborne diseases prevalent in surface water; water pollution, especially of fishing areas, resulting from the use of commercial pesticides; ground water contamination by naturally occurring arsenic; intermittent water shortages because of falling water tables in the northern and central parts of the country; soil degradation and erosion; deforestation; and severe overpopulation.

Due to the limited availability of surface water during the dry season, groundwater has become an increasingly important source of water for irrigation, municipal and industrial purposes. A number

of adverse effects have been observed due to over-exploitation of groundwater, such as the lowering of water tables, reductions in dry season flows of rivers and streams, groundwater pollution, the intrusion of saline water in coastal areas, ecological imbalance and possible land subsidence. There has been evidence of permanent depletion of groundwater levels in some locations, particularly in the Dhaka metropolitan area, where the average annual decline in the water level is about 3m, and in the northwest region of the country.

The area salinized by irrigation was estimated at 1,000km<sup>2</sup> in 1993.

Irrigation water quality has deteriorated in some locations due to pollution with agrochemicals, industrial waste and other sources. Arsenic contamination of groundwater, particularly HTW and water from STWs, has been reported in 59 out of 64 districts of the country in many government and donor agency documents. Arsenic concentration has been found to be at its highest level within the upper 50m of aquifers in most regions of the country (Water Aid, 2000). In many places, the concentration of iron and arsenic in irrigation water has gone beyond the limit of the safe water quality standards of Bangladesh and the WHO. A number of diseases and health problems, including arsenicosis, blindness and physical disability, occur due to arsenic toxicity to human body.

In some parts of the country, particularly the Barind Tracts within the northwest region, there are already symptoms of deterioration in the natural hydrological regime, effects on soils and the growth of agricultural crops resulting from poor water quality, and health hazards and effects on flora and fauna due to the decline in groundwater levels. Careful consideration should therefore be given to these environmental issues in order to harness the beneficial uses of irrigation water composed of both surface water and groundwater resources.

## 2. GOVERNANCE ASPECTS

### 2.1. WATER INSTITUTIONS

In Bangladesh, public-sector involvement in irrigation water management (IWM) is shared among three ministries. Minor irrigation and small-scale surface irrigation schemes lie within the jurisdiction of the Ministry of Agriculture (MoA) and the Ministry of Local Government, Rural Development and Cooperatives (LG&RD), respectively. Large-scale irrigation schemes, including FCD projects, are the responsibility of the Ministry of Water Resources (MoWR).

The MoA is mainly concerned with agricultural policy development, planning and monitoring. Project delivery is the responsibility of its various agencies, the most important being the Bangladesh Agricultural Development Corporation (BADC). In the past, the BADC was directly involved in supplying inputs to minor irrigation and looked after the O&M of all sorts of equipment. However, it has now withdrawn from all commercial operations relating to minor irrigation, leaving them to the private sector. The Department of Agriculture Extension (DAE) provides information to farmers on crops, agronomic practices and the use of on-farm water management and agricultural machinery. The Barind Multipurpose Development Authority (BMDA) under the MoA is also responsible for water resource management in the agricultural

development of the Barind Tracts region.

The Local Government Engineering Department (LGED) under the MoLG&RD implemented Small Scale Water Resources Development (SSWRD) projects Phase I and II by constructing 26 rubber dams in small and medium-sized rivers in different parts of the country. The LGED was also responsible for participatory management of these projects through the formulation of Water Management Cooperative Associations (WMCAs) for each project. Recently, the Bangladesh Rural Development Academy (RDA) under the MoLG&RD began implementing Multi-purpose Low-Cost DTW Projects in different parts of the country with a view to achieving optimum utilization of water resources for irrigation, fisheries, livestock rearing, nurseries, and domestic and other uses. These multiple uses bring significant benefits for people's livelihoods, especially those in poor households.

Under the MoWR, the Bangladesh Water Development Board (BWDB) is responsible for the planning, implementation and operation of medium- and large-scale surface water irrigation schemes and FC and FCD projects. The Water Resources Planning Organization (WARPO) under the same ministry has a mandate to ensure coordination of all relevant ministries through the National Water Council and to plan all aspects of water resources development, including large-scale and minor irrigation, navigation, fisheries and domestic water supplies.

### 2.2. WATER MANAGEMENT

Water Management (WM) is considered as the planned development, distribution and use of water resources, in accordance with predetermined objectives with respect to both quantity and quality of water. WM deals with the integration of all activities aimed at a systematic control of the inter-relationship between water and society with the main purpose of decreasing damage caused by water on the one hand and, on the other, exploiting it in a technically and economically viable way. WM is now the central issue in combating the increasing pressure on available water resources.

Agriculture is the greatest consumer of water resources, accounting for approximately 88 percent of all fresh water withdrawn. Modern high-yield and diversified crop production systems can be sustained only with proper utilization of irrigation water and management at the farm level.

Though there has been a significant increase in irrigated agriculture in the country over the last decade, most of the minor and major irrigation systems have shown poor field performances due to lack of technical know-how and poor on-farm water management (OFWM) practices. The Government has recognized the importance of introducing appropriate WM techniques and technologies at farm level as a means of supporting food security, employment and the elimination of poverty through the intensification and diversification of agricultural production. In view of this, the MoA has undertaken various development projects for improving the efficiency and overall performance of irrigation systems through better OFWM practices. Some investment projects were initiated by the Government; others were financed by donor agencies under the Technical Assistance (TA) programme.

The participation of women in WM activities has not been encouraged, though their participation in other agricultural practices – such as post-harvest processing, home gardening, and the rearing

of livestock and poultry – is widespread in many villages. In some places, however, treadle pumps for irrigation are operated by women; moreover, indigenous and tribal women are involved in collecting water for domestic purposes and irrigating homestead gardens.

### **2.3. WATER POLICY AND LEGAL FRAMEWORK**

In Bangladesh, no policy or act related to irrigation or water management has yet been formulated. In response to the rapid growth of minor irrigation through the use of DTW and STW during the 1980s, the MoA enacted the Groundwater Management Ordinance in 1985 controlling the spacing of irrigation equipment. But this Ordinance was suspended in 1987 with a view to the expansion of minor irrigation (mainly STW irrigation) to the private sector. Due to this suspension of space requirements for irrigation equipment, optimum utilization of groundwater resources has been impeded. However, in recent years, Government policies such as the MoA's 1999 National Agriculture Policy (NAP), the MoWR's 199 National Water Policy (NWPo) and the MoWR's 2001 National Water Management Plan (NWMP) have to some extent addressed minor irrigation and water management issues.

Minor irrigation has largely been the domain of private sector agriculture, where it has resulted in a significant increase in crop production, and there has been rapid expansion in the use of irrigated agriculture. With this in mind, the Government placed special emphasis on minor irrigation development in the 1999 NAP. In relation to irrigation water management, the mandate of the NWPo is to focus on increasing efficiency through drainage water recycling, rotational irrigation, water-conserving cropping patterns and the conjunctive use of both surface water and groundwater, non-point pollution of water systems by fertilizer and pesticides, and equity and social justice. The NWMP, formulated by the MoWR in 2001, is mandated to address the overall water resources management issues of Bangladesh and provide direction for short-, medium- and long-term action plans. In the NWMP, emphasis has been placed on the expansion of private STW irrigation in the slow-growth regions, and issues related to arsenic pollution and salinity – especially in the coastal areas – are to be addressed.

### **3. GEOPOLITICAL ASPECTS**

India controls the flow of the Ganges through a dam completed in 1974 at Farraka, 18km from the border with Bangladesh. This dam was a source of tension between the two countries, with Bangladesh asserting that the dam held back too much water during the dry season and released too much during monsoon rains.

A treaty was signed in December 1996 under which Bangladesh is ensured a fair share of the flow reaching the dam during the dry season. Similar agreements for other transboundary rivers are yet to be made.

### **4. RELIGIOUS AND CULTURAL ASPECTS**

In most religious traditions, water is central to physical and spiritual life, symbolizing purification, rebirth, and fertility. This concept continues to play a significant role in modern water-related

attitudes and actions. Hindus believe that bathing in the waters of a holy river, such as the Brahmaputra in Bangladesh and the Ganges in India, will cleanse one's life of past sins.
