Country Aspects

1. PHYSICAL ASPECTS

1.1. WATER RESOURCES

1.1.1. WATER RESOURCES

The country is divided into five watersheds comprising the 19 watersheds in the country. Total internal renewable surface water totals about 9.8km³/year for the whole country. The renewable groundwater resources contained in groundwater in the north of the country are estimated at about 1.5km³. These resources are mainly fed by precipitation, the distribution of which is irregular in terms of both time and region. The southern region is characterized by the existence of underground water resources. If one considers that there is no common part between surface water and groundwater, total internal renewable resources amount to 11.3km³. Exploitable resources are estimated at 7.9km³.

The initial total capacity of the dams of the five watersheds was around 5km³ in 2000. In 2003, the total capacity was estimated at about 6km³, but it is estimated that, with silting, this capacity has decreased by more than 25 per cent.

Desalination of seawater is practiced at 14 stations located in three watersheds for a capacity of 47,000m³/day (5,000m³/day in Oran and Constantine and 37,000 m³/day in Algiers), or 17.16 million m³. The construction of a station in Arzew will increase this capacity. The annual volume of sewage discharged is estimated at 600 million m³ and that of industrial wastewater at 220 million m³.

1.1.2. WATER USE

Water withdrawals are estimated at 6.07 billion m³ in 2000, of which 3.94 billion was for irrigation (65 per cent), 1,335 billion for domestic use (22 per cent) and 801 million for use by industry (13 per cent).

1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

Pollution of water resources has begun to assume alarming proportions, particularly in the north, where most of these resources are found. In terms of quality, 44 per cent of all waters are thought to be good, 44 per cent satisfactory and 12 per cent poor. The water used for irrigation is generally of average quality and mineralization.

The development of agriculture has led to the degradation of the quality of water for other uses (for instance, through nitrate pollution of freshwater aquifers used for human drinking water). In turn, the use of water by the population has resulted in biological and, increasingly, physico-chemical pollution.

The water quality maps published by the ANRH show that significant parts of rivers in the basins of Tafna, Macta, Cheliff and Soummam Seybousse are now polluted. Cheliff basin, with two million inhabitants, is thus exposed to pollution that may jeopardize the water supply of almost all of the localities served by the valley.

Coastal basins and that of Oran Cheliff are most affected by salts. Overexploitation of coastal aquifers is reflected by increasing irremediable saline intrusion. The water of the Terminal Complex is very salty, and that of continental infill very hot (50°C). Similarly, nitrates pollute the water of Mitidja in its eastern and western parts (subject to monitoring from 1985 to 1993); investigations into the upper Cheliff and the web of Sidi Bel Abbes led to similar conclusions. Water at the Keddara dam is particularly hard, and must be mixed with ground water to soften it before delivery. Finally, levels of manganese and chloride in the water supply of Constantine are close to the maximum allowed by the World Health Organization.

Insufficient water resources, non-compliance of water supply systems and sanitation, use of inappropriate technical processes, the phenomenon of cross-connection in the networks and squatter settlements, and the reuse of untreated or inadequately treated sewage explain the persistence of waterborne diseases. The 5-29 age group is the most affected by these diseases. Statistics from the National Institute of Public Health (NIPH) show an increased incidence of viral hepatitis in 1997 without significant decrease for the period 1997-2000; the same applies to typhoid and dysentery.

2. GOVERNANCE ASPECTS

2.1. WATER INSTITUTIONS

The most active authorities in water management are: the Ministry of Water Resources (MRE): Directorate of Hydraulic Studies (DEAH), the Directorate of the Mobilization of Water Resources (DMRE), the Department of Drinking Water Supply (DAEP), the Directorate of Sanitation and Environmental Protection (SBD), the Directorate of Agricultural Hydraulics (DHA) and the Department of Planning and Economic Affairs (DASP).

At the intermediate level, the MRE has:

- Three agencies (public administrative institutions): the ANRH, the National Dam (ANB), and the National Agency for the Conduct and Management of Water Infrastructure for Irrigation and Drainage (AGID), responsible for developing large irrigated areas and supporting the management of irrigation facilities;
- Five watershed agencies (public, industrial and commercial) under the supervision of the MRE, created under the 1996 Water Policy. These are Hodna-Soummam Algiers, Chellif-Zahra, Constantine-Seybousse Mellegue, Oran Chott-Chergui, and Sahara. These five agencies are responsible for the integrated management of water resources;

•Offices of irrigation (OPI), responsible for the management of IPA.

Also relevant are the National Water Council (CNE), the Ministry of Interior and Local Government, the Ministry of Agriculture and Fisheries, and the Ministry of Planning and Environment (MATE).

With regard to drinking water and sanitation, Algérienne des Eaux (ADE), founded in 2001, is responsible for ensuring, throughout the national territory, the implementation of national water policy through the management of activities relating to the production, transport, processing, storage, supply, distribution and supply of drinking and industrial water and the renewal and development of related infrastructure. The National Sanitation Office (ONA), also created in 2001, is responsible for protecting the water environment and for the implementation of the national sanitation policy in consultation with local communities.

2.2. WATER MANAGEMENT

Until 1985, management was entrusted to the subdivisions attached to the directors of water resources in each wilaya. In 1985, IPOs were created, responsible for the management, operation and maintenance of water infrastructure schemes. The financial resources of these offices come from irrigation charges. Given the nature of boundaries, and in order to meet management requirements, two types of organization were created:

- Five offices of a regional nature, responsible for the management of large irrigation schemes: Mitidja Valley, Cheliff, Habra, Sig, and Oued El Tarf-R'Hir;
- Eight offices managing small and medium-sized irrigation schemes: Bechar, Tlemcen, Saida, Boumerdes, Bouira, Bejaia, Tizi-Ouzou and M'sila.

The contractual framework for managing IPOs is the concession system, as defined by the Water Code of 1983 and amended in 1996. The concession contract with the IPO comes with specifications that define the rights and obligations of both parties.

Exploitation of TDC in irrigated areas is provided primarily by private farmers and secondarily by associations.

2.3. WATER POLICY AND LEGAL FRAMEWORK

Algeria's land policy is based on the distribution of land-use rights for the sole benefit of resident farmers who "directly and personally work the earth" and whose sole income comes from agricultural work (Decrees of March 1963 on self-management and Order of November 8, 1971 on the agrarian revolution). The adoption of Law 87-19 of December 8, 1987 determined which kinds of agricultural land were in the national domain and established the rights and obligations of producers.

Regarding the water sector, the key texts that have been promulgated are:

- Law No. 83-17 of 1 July, 1983: Water Code (supplemented by Ordinance No. 96-13 June 1996) based on five principles: (i) integrated management, (ii) economic management, (iii) decentralized management coordinated within the watershed, (iv) user participation in management, and (v) the compatibility of water management with policy planning and protection of the environment;
- Law No. 83-03 of 5 February, 1983 on the protection of the environment;

- Law No. 85-05 of 15 February, 1985 on the protection and improvement of health;

- Laws No. 90-08 of April 17, 1990 and No. 90-09 of 27 April, 1990 on competencies in water-related public service;

- The Finance Act 1992, imposing a tax on pollution and endangerment of the environment;

- Decree No. 210 of 3 March, 1992 pertaining to the legal status of water management and distribution;

- Decree No. 93-160 of 10 July, 1993 regulating the discharge of industrial effluents;

- Decree No. 93-100 of 6 March, 1996 on the definition of the watershed;

- The Finance Act 1996, concerning water quality and the water economy;

- Decree No. 96-301 of 15 September, 1996 laying down detailed rules for charging for water for industrial, agricultural and sanitation uses, and related prices;

- Decree No. 96-472 of 18 December, 1996 establishing the CNE;

- Decree No. 94-119 of 1 June, 1994 on the revision of the status of irrigation boards;

- Decree No. 97-253 of 8 July, 1997 concerning the concession of public services of water supply and sanitation;

- Decree No. 2000-324 of 25 October, 2000 establishing the powers of the MRE;

- Two other decrees of 25 October, 2000 concerning agricultural water activities;

- Decree No. 02-187 of 26 May, 2002 laying down the organizational and operational specifications for the provision of agricultural water services in each wilaya.

3. GEOPOLITICAL ASPECTS

Although Algeria is included in the basins of Lake Chad and the Niger river, it is not a member of the Commission of the Lake Chad Basin (LCBC), which concerns only the conventional basin of Lake Chad, or the Niger Basin Authority (NBA).
