1.1. WATER RESOURCES

1.1.1. WATER RESOURCES

Total mean annual runoff calculated or measured at the entrance of the wadis in the plains (or spreading zones) is roughly estimated at 200 million m³/year, but a large part of it evaporates or recharges the underlying aquifers. Therefore, the regular renewable surface water resources are estimated at 100 million m³/year. Currently there are 16 dams in operation with a crest higher than 10 metres. No new dams are under construction, but rehabilitation of the Wadi Qattara main dam and reconstruction of the secondary dam have just been started. A number of new dams are planned, but construction has not yet begun due to financial constraints. The total storage capacity of these dams is 385 million m³ with an average annual storage capacity of about 61 million m³.

The total average annual design storage figure does not necessarily correspond to an additional water resource. For example, the actual flow records (1982-1991) of Wadi Ghan indicate an average storage of only 3.99 million m³/year, as opposed to the design figure of 11 million m³/year. Moreover, certain dams (including Wadi Qattara) have been damaged and are not in a position to store the amount of water they were designed for. It is estimated that the real average water resource made up by the existing dams does not exceed 30 to 40 million m³/year.

Currently, aquifers are recharged only in the northern regions: Jabal Nafusah and Jifarah plain in the northwestern zone and Jabal al Akhdar in the northeastern zone. Renewable groundwater resources are estimated at 500 million m³/year. South of latitude 29° north, an important development of Palaeozoic and Mesozoic continental sandstone enabled water to be stored safely during the long period of the late Quaternary, before the climate turned extremely arid. Most water used in Libya comes from these huge fossil reserves. Groundwater occurs in four systems which are relatively independent from each other, as follows:

1. The western aquifer system including three interconnected sub-systems:

-the Murzuq basin;

-the Jabal Hasawnah, which will play an important role in the future as a water source for the western water transport system; and

-the Al Hamadah al Hamra system including the Jabal Nafusah Suf-Ajjin-Tawurgha sub-basin, the Ghadamis sub-basin and the Al Hamadah al Hamra system.

2. The Jifarah plain system.

3. The As Sarir Al Kufrah basin system.

4. The Al Jabal al Akhdar system.

There have been several attempts during the last 25 years to introduce and expand seawater

desalination plants and wastewater treatment facilities. A number of desalination plants of different sizes have been built near large municipal centres and industrial complexes. However, so far restrictions have been imposed by the high cost of energy and spare parts. The contribution of the existing desalination plants is almost negligible and is exclusively used for municipal and industrial purposes. The existing operating capacity of the installed plants is about 65 million m³/year, but the total amount of water produced is only between 20 and 30 million m³/year since most of the desalination plants are not in good operating condition. The present level of wastewater treatment is estimated at about 40 million m³/year. All treated wastewater is used for agricultural purposes.

1.1.2. WATER USE

The total abstraction of 4,200 million m³/year is about eight times the annual renewable groundwater resources and therefore Libya depends heavily on fossil groundwater. The coastal aquifers are the only ones that are being recharged by rainfall, but uncontrolled groundwater development from these aquifers exceeds the annual replenishment. This has caused a severe water level decline and seawater encroachment, which makes the coastal groundwater resources almost unusable because of their high salinity.

This situation has accelerated the process of water transfer through the implementation of the Great Manmade River Project (GMRP), which was launched in the early 1980s and is designed to eventually transport 2,300 million m³ of fossil water from the Libyan south, where a huge amount of fossil groundwater has been stored since the late Quaternary, to the north, where the water is urgently needed. The project is ongoing and consists of five phases, of which Phase I and II are currently being implemented. For Phase I, two well fields in the As Sarir - Al Kufrah basin have been designed to convey 730 million m³/year to the coastal areas extending from Benghazi to Sirt. The first well field is located in the Sarir area and currently produces 94 million m³ of water, which is 25-30 per cent of its capacity. The second well field is located near the village of Tazirbu, some 200km south of the Sarir well field, and is under construction. Phase II consists of several well fields in the Jabal Hasawnah area, designed to transport some 910 million m³/year to the Jifarah plain around Tripoli. The first wells are now in operation and produce about 140 million m³/year. The GMRP is designed mainly to serve irrigated agriculture, but until now the water has been used almost exclusively for municipal and industrial purposes in the major cities of the country.

Of the total water withdrawal of 4,268 million m³, about 83 per cent is used for agricultural purposes, 14 per cent for municipal use and 3 per cent for industrial use. More than 30 per cent of the present municipal water demand is supplied by the GMRP. Most of the industrial water is used for the oil industry (injection, processing and some municipal use).

According to the assumptions made about water productivity in agriculture, the total water requirement to support basic food self-sufficiency and to meet the municipal water demand of the

12 million Libyans in the year 2025 is estimated to range between 10.5 and 16.4km³/year, compared to 4.3km³/year at present. When the GMRP is fully operational, the total amount of water available for all uses - assuming that the present groundwater production equipment will be maintained until 2025 - will be in the order of 6.5km³/year and will thus barely cover 50 per cent of the total water requirement.

1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

In the last decade, private agriculture developed rapidly. Along the coast this led to uncontrolled development of the coastal aquifers, exceeding the annual replenishment. This caused a severe water level decline and seawater encroachment, making the coastal groundwater resources almost unusable because of their high salinity. Currently, groundwater abstraction from private farms corresponds to 47 per cent of the total abstraction and is the main sector of water use, but it almost completely lacks a water resources monitoring system.

An inadequate sanitation system in the urban agglomerations (mostly in Jabal Akhdar but also around most of the cities of the south) leads to severe pollution of the shallow aquifers around the cities. Important water abstraction, either for local agricultural projects or for water transport to the coast, will cause a significant water level decline in the aquifer, due to the non-renewable character of the water sources. This will slowly induce the disappearance of natural vegetation which is still important in the Wadi ash Shati or Ghadamis oases.

Improper irrigation and drainage practices have resulted in substantial degradation of soil in the southwestern part of Libya. The planned use of transport water for irrigation along the coast of Sirt where brackish aquifers exist at a shallow depth may also result in waterlogging and salinity problems if appropriate irrigation and drainage techniques are not applied.

2. GOVERNANCE ASPECTS

2.1. WATER INSTITUTIONS

The responsibility for all water resources assessment and monitoring rests with the General Water Authority (GWA) which was established in 1972. The GWA is composed of six general directorates: planning, follow-up and statistics; water resources; dams; irrigation and drainage; soils; and finance and administration. It is concerned with the supervision of irrigation and drainage projects. Furthermore, it performs research and studies aimed at improving the irrigation network and it organizes on-the-job training programmes for its staff. It has a documentation centre and has recently established a system for data storage and retrieval linked to GIS. It also has a central laboratory equipped for various analyses related to water and soils.

The Secretariat of Agriculture and Animal Wealth is responsible for the development of irrigated agriculture and the implementation of major projects. A special authority, known as the Great Manmade River Water Utilization Authority (GMMR), is responsible for the use for agricultural purposes of the water transported from the desert to the coast. The Secretariat of Municipalities takes care of the water supply to urban settlements. At present, no water fees are imposed on

users of water for irrigation purposes.

The housing and utilities department operates all domestic water supply well fields, pumping stations and distribution networks, and provides metering and chlorinating services. It is also responsible for the design, construction and operations and maintenance (O&M) of sewage treatment plants [Bindra, 2003].

The energy department is in charge of design and O&M of major desalination plants. It also undertakes implementation of the large-scale ground water conveyance scheme, which is the responsibility of the GMMR Authority [Bindra, 2003].

2.2. WATER MANAGEMENT

The deficit in the water balance has been growing continuously since the early 1960s. It started in the coastal areas with intensive irrigation, and spread southward to include oases, wadis, agricultural project areas and urban centres. The annual drop in water levels varies from less than one metre to over five metres and leads to the dryness of shallow aquifers and their invasion by seawater or surrounding saline water [Al Miludi].

This has prompted the authorities to adopt certain measures to cope with the fast deteriorating water situation. These measures include legislation to: regulate licensing for water use; control irrigation times; ban high water-consuming crops and trees in the affected zones; and charge for domestic and industrial water consumption. When it is completed the GMRP will convey more than 6 million m³ of fresh water per day from the basins of Kufra, Sarir and Murzuk to the northern plains. Other measures have included expanding the construction of seawater desalination and sewage treatment plants. Two main objectives of the national water policy can be defined as [Al Miludi]:

- minimizing the water budget deficit; and
- preventing water quality deterioration.

These objectives cannot be achieved without the full cooperation of policy makers, water users, and the public at large.

2.3. WATER POLICY AND LEGAL FRAMEWORK

A national committee was formed in 1996 and was entrusted with the re-evaluation of the present water situation and the proposal of a national water strategy. The committee submitted its final report in 1999, from which the following recommendations are summarized:

Capacity building and institutional reforms: in addition to intensifying training activities in the field of water resources it is necessary to establish a national water council to be entrusted with the development and implementation of national water policies and in particular:

- integrated planning covering all water related sectors;
- ensuring balanced socio-economical development in the water regions;
- restructuring water institutions to ensure efficient performance;
- defining priorities of water use based on social and economic values; and
- ensuring the independence of the water authority

Minimizing water deficits (demand management):

- reducing water use by minimizing losses, especially in irrigation; and
- re-orienting agricultural policies through:
 - limiting horizontal expansion in water stress areas;
 - re-defining self-sufficiency and food security principles to include only basic food items;
 - the application of the safe yield principle for groundwater extraction from renewable aquifers;
 - the use of treated sewage water to irrigate fodder;
 - a gradual change in food consuming patterns;
 - banning the export of agricultural products;
 - enforcement of the laws and regulations governing water extraction and drilling, along with strengthening law enforcement authorities;
 - upgrading the efficiency of irrigation systems;
 - lifting subsidies on less efficient irrigation systems and raising custom duties and taxes to limit their use;
 - educating farmers on modern irrigation systems;
 - and encouragement of dry farming.
- Re-programming the utilization of the GMRP: the total volume planned for conveyance from south to north exceeds 6 million m³/day (2.2 billion m³/year) devoted primarily to agriculture. To optimize the benefit from the project, water needs to be re-allocated so that priority is given to domestic use, followed by industry, with the remaining portion used to substitute irrigation water in water stress areas and in existing agricultural projects.
- Reducing domestic and industrial water requirements by controlling losses and improving existing technologies;
- Water pricing;
- Water is a public commodity that should be given a social value in addition to the cost of providing it in order to generate funds necessary for operation and maintenance of water supply systems. Water pricing should therefore include agricultural, industrial and domestic uses.
- Public awareness: It is estimated that between 20 and 40 per cent of water could be saved by engaging public information systems in improving user behaviour and understanding of water issues, especially in the field of agriculture.
- Development of conventional and non-conventional water resources:
 - updating information on groundwater basins and in particular those of Kufra, Sarir and Murzuk and intensifying hydrogeological studies and surveys;
 - implementing available schemes for the construction of additional dams and reservoirs in order to double the average storage capacity; and
 - providing funding for major desalination and sewage treatment plants and creating an independent institution to manage these projects.
- Protection of water resources from pollution;
- Reviewing and updating water legislation to cope with modern developments in water management;

-Environmental protection; and

-Technical cooperation: cooperation with regional and international organizations as well as bilateral and multilateral cooperation with neighbouring countries for better management of shared groundwater basins.

3. GEOPOLITICAL ASPECTS

Libya has a total area of about 1.76 million km². It is bordered in the north by the Mediterranean Sea, in the east by Egypt and Sudan, in the south by Chad and Niger, and in the west by Algeria and Tunisia.

Libya shares large groundwater basins with neighbouring countries, the most important of which are the Nubian Sandstone basin with Egypt, Sudan and Chad, and the north Sahara basin with Algeria and Tunisia. The other main sandstone aquifer is the Continental Intercalaire shared between Libya, Algeria and Tunisia [Salem, 2007].

Libya ratified the United Nations Convention on the Law of the Non-Navigational Uses of International Watercourses (UNTC) on 14 June 2005.
