## Country Aspects

### 1. PHYSICAL ASPECTS

#### 1.1. WATER RESOURCES

##### 1.1.1. WATER RESOURCES

Rwanda's drainage system is abundant and dense. There are two major river basins and the watershed line is the "Congo-Nile".

The Upper Nile basin, which covers 76 per cent of the country, catches 90 per cent of the available water through the Nyabarongo and the Akagera, the main tributaries of Lake Victoria and source of the White Nile. The Akagera basin contributes water to the Nile. The Congo-Nile basin covers the remaining 24 per cent of the country and attracts 10 per cent of the country's waters from Lake Kivu to Lake Tanganyika.

Water covers about 8 per cent of Rwanda (211km<sup>2</sup>). Lakes cover 1281.9km<sup>2</sup>, Lake Kivu making up 80 per cent of this. Rivers and swamps cover 72.6km<sup>2</sup>. The marsh feeds most lakes and rivers. The surface water of lakes and rivers in Rwanda is generally charged with silt and sediment due to erosion.

The total area of wetlands in the country is estimated at about 1,650km<sup>2</sup>, made up of 530km<sup>2</sup> of primary network, which includes large swamps that line the major rivers (Mwogo, Nyabarongo, Akanyaru and Akagera) and 1,120km<sup>2</sup> of lower river systems, consisting of small and medium marsh and shallows. Apart from the Akagera Park, none of the marsh is protected. However, the Ramsar Convention described five marshes as being of crucial importance for biodiversity protection.

Groundwater is still unexplored, except for some holes drilled by projects and a limited inventory cataloguing 22,000 groundwater sources in the country. However, erosion of very important watersheds is not conducive to normal recharge of groundwater.

##### 1.1.2. WATER USE

In 2000, estimated total water withdrawal was 1.5 million km<sup>3</sup>. Agriculture used 68 per cent of this, the domestic sector used 24 per cent and industry only 8 per cent.

#### 1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

Major environmental problems in Rwanda include: deforestation resulting from uncontrolled logging of trees for fuel; overgrazing; soil exhaustion; soil erosion; and widespread poaching.

Water pollution is uncommon because of the low level of industrial activity and employment of agricultural inputs. However, microbiological pollution due to large concentrations of people is often observed. Water hyacinths choke some lakes and streams, including lakes Victoria and

Cyohoha Rwero and rivers Nyabarongo and Akagera.

Deforestation, particularly in upper watersheds, and unplanned land occupation have resulted in serious erosion problems, degrading millions of square kilometres. The latter has a significant impact on water flows downstream, causing deteriorating water quality of rivers, lakes and marshes due to sedimentation and pollution from the source.

The main environmental risk is drainage which, if too deep, tends to cause lasting or irreversible marsh damage.

### 2. GOVERNANCE ASPECTS

#### 2.1. WATER INSTITUTIONS

Institutions active in managing water resources and land are:

-The Ministry of Agriculture and Animal Resources (MINAGRI), through the Unit for Agricultural Engineering and Soil Conservation. MINAGRI is responsible for the rational use of water for agricultural purposes;

-The Ministry of Lands, Environment, Forestry, Water and Natural Resources, through its Directorate of Water and Sanitation, is in charge of rural water supply and managing water resources and sanitation. Its main tasks are to update and implement national water and sanitation policy; develop strategies for water supply; control water quality; and raise public awareness of the issues of transport, treatment and water conservation at home;

-Electrogaz, established in 1976 (Decree-Law No. 118/76) and formerly a public company, is responsible for producing and distributing electricity and water in urban areas. However, it is losing money and is unable to meet the needs of the population. Its monopoly was lifted by Law No. 18/99 in 1999;

-Water districts, who legally own rural pipes (Presidential Decree No. 291/11 of 15 May 1987). The new policy of decentralization reinforces this responsibility, giving local communities the right to delegate management to authorities or private companies.

#### 2.2. WATER MANAGEMENT

For the development projects in the wetlands, the redistribution of land is based on equal basis principle, regardless of the local water situations. Prior to this development, the individual plots were planned based on the nature of the land or soil quality and access to water, determined in consultation with various local experts in the interests of fairness and based on good knowledge of the terrain. With these new developments, there exist fear the new are determined without their knowledge of local water realities. Normally, the planning and land allocation are done by the district, while maintaining the managed wetlands with collective work, such as the rehabilitation of irrigation and drainage is the responsibility of associations. A personal debrief (irrigators cleaning,

repairing dikes, grading) should be provided after each crop harvest. Nowadays, maintenance is very poor due to lack of adequate technical support and lack of motivation of farmers. Side technicians, lack of irrigation specialists makes the problem even more acute due to lack of staff able to explain the functioning of irrigation to users.

### 2.3. WATER POLICY AND LEGAL FRAMEWORK

Statutory law and customary law both provide land tenure rights. The first recognizes land ownership due to private appropriation (registration, land registration, title). It allows a very small minority of the population with more means to acquire property and have absolute rights over the land. Customary law gives poorer people the right to use important areas, but the state remains the land owner.

The Decree of 11 July 1960 on land tenure states that all land and swamps are the exclusive property of the state and can be made available to the public for their use and benefit. However, the government has the unconditional right to take back the land to redistribute it or for other public uses. In this case, the occupier of the land is compensated. Tenure security is not guaranteed, which leads to a lack of investment in agriculture and wetlands sustainable management.

In 2004, MINITERE prepared a new land law, which parliament passed, defining land ownership, rights and obligations of owners of land and land transactions. The law recognizes the private domain of individuals, the land area of the state and land issues of commons areas.

Water is considered a common good: it belongs to everyone, but is not owned by anyone, not even the state. Water management is under government control in the public interest. While no one can own water, people may have the right to use it.

The water sector's policy to meet the water needs of the country, currently being prepared for MINITERE, contains the following points:

- i) Management of water resources;
- ii) Increasing access to potable water;
- iii) Increasing access to water for agricultural use;
- iv) Development of sanitation and hygiene;
- v) Use of water as an energy source;
- vi) Water control for protect the environment.

The policy aims to ensure fair and sustainable access to water for everyone. It stresses the importance of protecting the main water sources: lakes, rivers, groundwater and wetlands in particular. It recognizes the role of both economic and social development of water and the importance of cooperation to manage international river basins. A draft water law has been prepared and adopted in 2005, which aims to strengthen the regulatory framework for the sustainable integrated management of water resources.
