1. PHYSICAL ASPECTS

1.1. WATER RESOURCES

1.1.1. WATER RESOURCES

Serbia's predominantly upland terrain can be divided into a northern region, which is part of the Pannonian Plain and intersected by the Danube, Sava, Tisza, Tamiš and Begej rivers, the Danube-Tisza-Danube canal system (DTD) and several lakes, and a more hilly and mountainous region to the south of the Danube which comprises the Rhodope, Carpathian, Balkan, Dinaric and Skardo-Pind mountains. This central-southern region connects to the southern Balkans via the Morava and Vardar/Axios Basins.

1.1.2. WATER USE

Groundwater is the primary source of municipal and industrial water supply, with a total municipal abstraction of c. 750 million m³ in 1991. Industrial water supply in 1991 was c. 615 million m³, with 175 million m³ used for irrigation. Less than three per cent of agricultural land is irrigated, and levels continue to decline. Hydropower is a significant power generator and water user in Serbia, accounting for 31 per cent of total energy production in 2004 (11,021GWh). There are 13 major reservoirs greater than 10 million m³ dedicated to energy production, e.g. Iron Gate I.

The waterway network extends over 1700km of the Danube, Sava and Tisza rivers as well as the 600km navigable part of the DTD system. All are directly or indirectly connected with the European inland network. Navigation improvements on the Danube have been systematic and continuous. The Tisza is navigable over 164km, and the Sava over 207km. The Sava is part of an international waterway connecting Croatia, Bosnia & Herzegovina and Serbia with the Danube.

Flood control is provided by levees on the major rivers of the Pannonian plain and central Serbia, where all major cities and significant industrial facilities are located in potential flood areas. Smaller rivers are prone to torrents, with frequent flash floods and landslides; control measures are only partially developed.

Considering flood risk, floodwater potentially threatens 245km² of farmland and urban areas. This is particularly pronounced in areas surrounding Lake Skadar and the Bojana River, Zeta Valley, Bjelopavlici, Plav ravine and areas around the Lim, Tara and Cehotina river valleys. Most of the existing land reclamation systems are currently not operational. Central and northern parts of the country (specifically the upper Tara and Lim regions) were hit by large floods during the last century (e.g. 1963 and 1979 and again in 1999 and 2000). The need for flood protection measures is particularly apparent in the areas near the larger rivers, namely Morača, Lim, Tara, Cehotina, Ibar and Bojana, and the large flat karst plain areas. Current work completed on river regulation

and flood protection is modest, mainly of local importance, and not adequate in terms of extension and functionality.

1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

Major environmental problems are air pollution around Belgrade and other industrial cities, as well as water pollution from industrial waste dumped into the Sava, which flows into the Danube. Changes in the Serbian economy have resulted in a major reduction in pollution emissions. The economic downturn and the transformation to private ownership has resulted in pronounced variations in industrial output since 1998. The list of significant point sources covers 46 communities and 14 industries – however many of the major industries are not covered due to lack of reliable data, and most industrial wastewater quality analyses do not include specific pollutants. Industry is a significant source of hydraulic wastewater volume, while the nutrient load is notably higher from municipal sources – due to the fact that municipal wastewaters are mainly discharged untreated, and that current industrial output is low.

Most small communities (fewer than 2,000 people) do not have wastewater treatment plants, and a number of existing plants are not operational. With a large proportion of the population living in small settlements (27 per cent in communities of fewer than 2000; 21 per cent in communities of 2,000-10,000), this has a significant impact for wastewater management.

The major municipal pollution sources stem from the cities of Beograd, Novi Sad and Niš, with emission levels >150,000PE. These areas discharge untreated wastewater and are sources of significant organic and nutrient pollution. Data on agricultural sources are not available.

2. GOVERNANCE ASPECTS

2.1. WATER INSTITUTIONS

Activities related to fresh water management (use, preservation, flood control, pollution control, water regime/quality and quantity, etc.) fall under the jurisdiction of the Ministry of Agriculture, Forestry and Water Management of the Republic of Serbia/Republic Directorate for Water.

In addition, the Ministry of Science and Environmental Protection and the some other ministries have certain roles in various aspects of water management.

JVP "Srbijavode" (Public Water Management Company – "Serbia Waters") was set up in 1996 to implement water management activities. The structure was altered in 2003 with the creation of the Provincial Secretariat of Agriculture, Water Management, and Forestry of Vojvodina Province and the setting up of the new JVP "Vode Vojvodine" (Vojvodina Waters) that covers water management responsibilities on the territory of Vojvodina Province. Field activities are carried out by 55 companies, under contractual arrangements with JVP "Srbijavode" and "Vode Vojvodine".

Water supply public companies are guided by the Ministry of Public Administration and local self-

government. The Ministry of Agriculture and Water Management is responsible for communicating water management criteria to these companies, as well as issuing permits for the use or release of water – and also encouraging and providing subsidies for construction of capital projects.

In addition to state bodies and institutions, the following government and non-government institutions are also important stakeholders in the water domain:

- Serbia Forests Public Enterprise (and Vojvodina Forests Public Enterprise);
- Energy Management Public Enterprise of Serbia;
- National scientific and professional organisations: universities, hydro-meteorological and other institutes, chambers of commerce, and other similar organisations and institutions;
- Non-governmental institutions: The Jaroslav Cerni Institute for the Development of Water Resources, numerous design, contracting and other companies, as well as numerous non-governmental environmental protection organisations.

2.2. WATER MANAGEMENT

The main instrument for water management is the Water Act, which regulates the use and protection of water resources at a project level. The Water Act, however, does not provide a framework for strategic and integrated planning of all sectors of water management – which include river engineering, torrent construction, wastewater management, water supply and freshwater protection.

Under the new European scenario, the Water Framework Directive prescribes that management activities should aim to achieve the goals of the directive within geographical areas or river basin districts (RBDs). These are based largely on surface water catchments, together with the boundaries of associated groundwater and coastal water bodies.

For each RBD, a river basin planning process must be set up. The first milestone of this planning process (analysis, monitoring, objective-setting and consideration of measures to maintain or improve water status) is the initial river basin management plan (RBMP).

These RBMPs should be made available for information and consultation by the public. The RBMP will:

- Record the current status of water bodies within the river basin district;
- Set out the measures planned to meet the objectives;
- Act as the main reporting mechanism to the Commission and the public.

The whole process of river basin management planning includes the preparation of a programme of measures at basin level for achieving the environmental objectives of the Water Framework Directive (WFD) cost-effectively. Basic measures include the control of pollution at source through setting emission limit values, as well as through setting environmental quality standards. The use of economic instruments, such as water pricing, is part of basic measures. Here, in particular, the “polluter pays” principle should be taken into account. The directive aims to ensure that pricing policies improve the sustainable use of water resources.

The planning, implementation and evaluation of the programme of measures is an iterative process that will probably include the RBMP of the first (2009), second (2015) or further cycles

(2021, 2027).

2.3. WATER POLICY AND LEGAL FRAMEWORK

The most important law that governs the water domain in Serbia is the Law on Waters (1991). It regulates the protection of water, protection against harmful effects of water, the use and management of waters as a resource of public interest, the criteria and methods of performing the water management activity, organization and financing of water management, and supervision of implementation of the law.

The lack of harmony between the existing Law on Waters and other laws, decrees, and regulations passed in the meantime and the inability to implement transformation of ownership in the manner prescribed by the existing law, as well as the split authority between the ministry and public water management companies and other various ministries, are only some of the reasons that necessitate a new Law on Waters.

New solutions should be in harmony with the WFD of the European Union (2000). Water management in accordance with new guidelines of the environmental domain and the principles of sustainable development are essential prerequisites for the proclaimed goal of the country to become a future member of the European Union.

This new Law on Waters was in final phase of preparation.

Basic goals to be achieved by the intended reform of the water sector include the following:

- Establishment of self-financing as one of the conditions for rational use and consumption of water, and protection of and against water;
 - Achievement of appropriate water conditions based on criteria set out in the European Water Directive;
 - Creation of conditions for economic, social, and health-related progress on the basis of improvement of the water management infrastructure;
 - Employment increase based on encouragement of investment in the water sector.
- Such goals impose the need to initiate reform as soon as possible, and to assure that the reform is implemented efficiently. This requires appropriate prerequisites which include legislation, financing system, organizational structure and ownership, among others. Numerous positive effects are expected from the reform, the most important being:
- Integrated water management;
 - Financing of water management along the principles of “user pays” and “polluter pays”;
 - Investment of national and international capital in water (achievement of investment and creation of new jobs);
 - Regulated water management – delineation of “vertical” and “horizontal” jurisdiction within the sector, and activities in harmony with other ministries concerned with water, for example, stable financing;
 - Rational water consumption based on saving measures which include higher degree of availability, more reliable communal water supply and greater irrigation coverage;
 - Improvement of water quality – for example, reduction of pollutant emission and better sewage

treatment;

-More reliable water control, which covers issues like effective flood control, improved drainage and higher degree of erosion control;

-Extended range and higher quality of services in the public sector, including adequate increase of overall employment.

3. GEOPOLITICAL ASPECTS

The Republic of Serbia place a high importance on the establishment of a new framework for multilateral cooperation, which would be closely linked to, and synchronized with, bilateral cooperation – along the lines of the major international conventions approved during the 1990s, during which time Serbia was isolated.

This particularly relates to the implementation of the European Water Framework Directive (WFD, 2000).

The following conventions significant to water management were ratified:

-The Convention on Cooperation in the Protection and Sustainable Use of the Danube River Basin (2003);

-The Budapest Declaration/Tisza Water Forum (2001).

Bilateral treaties on the regulation of water management relations have been signed with the neighbouring states of Hungary, Romania, Bulgaria and Albania (last two are only formally in force, but not implemented in practice).
