## Country Aspects

### 1. PHYSICAL ASPECTS

#### 1.1. WATER RESOURCES

##### 1.1.1. WATER RESOURCES

Tajikistan can be divided into four major river basins:

-The Syr Darya basin. The northwest of the country forms part of the Syr Darya basin. About 78 per cent of the flow of the Syr Darya River is generated in the Kyrgyz Republic. Only 1 per cent of the river's total flow is generated within Tajikistan by the shallow rivers Khodzhabakirgan, Aksu, Isfara and Isfana, with a total flow of 0.4km<sup>3</sup>/yr.

-The Amu Darya basin. About 82.5 per cent of the Amu Darya River's flow is generated in Tajikistan by the Vakhsh, Pyandzh and Kafirnigan rivers. The Vakhsh River is the largest river in Tajikistan, crossing the country from the northeast to the southwest. It rises in the Kyrgyz Republic, where it is called the Kyzyl Suu, and its catchment area lies in the highest part of Tajikistan at over 3,500m. The Pyandzh River forms the border between Tajikistan and Afghanistan for almost its entire length. After the confluence with the Vakhsh River, it becomes the Amu Darya River and about 100km further downstream it leaves Tajikistan to become the border between Afghanistan and Uzbekistan. The Kafirnigan River is another large tributary of the Amu Darya River. It rises in Tajikistan and flows into the Amu Darya River about 36km downstream of the confluence of the Pyandzh and Vakhsh rivers.

-The Zeravshan basin. The Zeravshan River, rising in Tajikistan, was once the largest tributary of the Amu Darya River. At present its flow is almost fully used, mainly for irrigation.

-The basin draining to China. In the extreme northeast of the country, a small area drains toward China. No figures on flows are available.

Tajikistan's estimated total internal renewable surface water resources stand at 63.3 km<sup>3</sup>/yr. During the Soviet period, the sharing of water resources among the five Central Asia republics was on the basis of master plans for water resources development in the Amu Darya and Syr Darya river basins. With the establishment of the Interstate Commission for Water Coordination in 1992, the newly independent states decided to prepare a regional water strategy (agreement of 18 February 1992), but to continue to respect the existing principles until the adoption of a new water sharing agreement. The surface water resources allocated to Tajikistan are calculated every year, depending on the existing flows. However, on average, it can be considered that the surface water resources available for Tajikistan are 12.98km<sup>3</sup>/yr.

Internally generated renewable groundwater resources are estimated at 6km<sup>3</sup>/yr, of which 3km<sup>3</sup>/yr overlaps with surface water resources. The part of groundwater resources for which abstraction equipment exists has been estimated at 2.2km<sup>3</sup>/yr.

##### 1.1.2. WATER USE

In 1994, total annual water withdrawal was estimated at 11.87km<sup>3</sup>, of which over 92 per cent was for irrigation purposes. About 2.26km<sup>3</sup> was groundwater, an estimated 0.35km<sup>3</sup> re-used collector-drainage water and wastewater for irrigation, and the remainder was surface water. In 1995, total water demand for all sectors was estimated at 12.955km<sup>3</sup>.

#### 1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

Major environmental problems in Tajikistan include inadequate sanitation facilities, increasing levels of soil salinity, industrial pollution and excessive pesticides.

The environmental problems in Tajikistan are the result of its climate and natural conditions (steep slopes) and the structure of the national economy. The irrigated area is subject to substantial erosion, land slides, sagging and deformation. The area affected is estimated to be about 450 km<sup>2</sup>. Irrigation development in the foothill zone, especially in the more stony areas, induces increasing groundwater recharge, intensifying water logging and salinization of the lower areas, and increasing the sediment-loaded drainage water runoff. Collector-drainage water is the principal water polluter (common mineralization, pesticides and some other waste ingredients). Environmental pollution is also increasing as a consequence of industrial production.

### 2. GOVERNANCE ASPECTS

#### 2.1. WATER INSTITUTIONS

The Ministry of Water Resources (MWR) is in charge of water resources research, planning, development and distribution. It also builds, operates and maintains the irrigation and drainage networks at inter-farm level. Water distribution is based on a strict limitation of water withdrawal. Water allocations are regularly reduced to promote water savings and to satisfy the demand from new users. Institutionally, water management follows a hierarchy: state, province, district, farm (or Water Users Association). The first three levels come under the MWR and are responsible for water distribution and delivery to the farm inlet, for assisting water users to implement advanced technology, and for controlling water use and water quality. The special reclamation services at provincial level are the MWR's responsibility. It monitors the irrigated lands (groundwater level, drainage discharge and soil salinity) and plans measures to maintain and improve soil conditions, including leaching, repair and cleaning of collectors and drainage network, and rehabilitation.

The Ministry of Agriculture is in charge of agricultural research and extension, agricultural and land reclamation development at farm level, and operation and maintenance of the irrigation network at farm level.

The state enterprise "Tajikjilkomkhov" is responsible for domestic water supply and the treatment

of wastewater. The Ministry of the Environment is responsible for the protection of water resources.

## **2.2. WATER MANAGEMENT**

Independence, the civil war and economic transition has weakened the personnel base the water system depends on. Many of the people who filled senior managerial and technical posts were Russian. Even before the breakup of the Soviet Union in 1991, skilled personnel had gradually been leaving Tajikistan. The lack of funds for recruiting and retaining highly qualified staff has had a severe negative impact on key agencies, both in weakening their professional culture and in hampering their performance in the field.

Opportunities for training and team-building are almost non-existent, leading to slow adoption of new technical and managerial approaches. Communication with regional offices is haphazard, with some ministries reporting that staff in the field are sometimes unaware of key policy changes. As a result of these personnel constraints, outmoded practices have persisted in spite of the clear need for efficiency-improving reforms.

A critical personnel issue concerns the highly specialized technical backgrounds of many professionals in the water sector. Narrow scientific specialization comes at a price: there is a real shortage of leaders in the sector with a sound, holistic understanding of the overall water system. With irrigation programmes neglecting drainage, supply systems neglecting sanitation, and end-pipe solutions for industrial waste being favoured over integrated treatment measures, the absence of integrated water policy and management has contributed to Tajikistan's failure to halt some of the unsustainable and damaging practices of the previous era. A new generation of policymakers capable of maintaining the high scientific standards of the current generation while also being able to see the linkages between disparate water-related sectors and the externalities associated with water use will be essential if Tajikistan wants to achieve sustainable long-term water use.

## **2.3. WATER POLICY AND LEGAL FRAMEWORK**

Water law and water rights are defined by the special "Water Code of Tajikistan", which was confirmed on 12 December 1993.

## **3. GEOPOLITICAL ASPECTS**

Five independent states – the Republic of Kazakhstan, the Kyrgyz Republic, the Republic of Tajikistan, Turkmenistan and the Republic of Uzbekistan — as well as part of Afghanistan are entirely or partly situated on the Amu Darya basin's territory.

After the Soviet Union collapsed, to prevent conflicts and serious complications in water resources management and to put water allocation, limitation and account in order, the ministers of five Central Asian states (N. Kipshakbayev, V. Melnichenko, A. Nurov, A. Ilamanov and R. Giniyatullin) met at a conference in Tashkent in October 1991. They agreed that only joint action could help solve the region's water problems in a context of increasing ecological and social tension.

In February 1992, the ministers signed an "agreement on cooperation in joint management, use and protection of interstate sources of water resources". This provided for the creation of the Interstate Coordination Water Commission.

The 1999 Ashgabat Declaration focused on the consequences of the Aral crisis, which had worsened the living standards of many in Central Asia.
