1. PHYSICAL ASPECTS

1.1. WATER RESOURCES

1.1.1. WATER RESOURCES

Tunisia's river network is dense in the north where the Medjerda is the most important river. The northern basins provide regular and substantial contributions relative to the rest of the country, supplying 82 per cent of surface water resources. Basins in the centre and south are characterized by low and irregular contributions. The north is also distinguished by its richness in shallow groundwater (in the northeast coastal plains). The centre is relatively well off in deep and shallow groundwater with an average to mediocre quality. The south is characterized by its low potential for renewable groundwater from continental infill (geothermal properties, temperature around 75°C).

Natural wetlands, such as sebkhs, lagoons and saline lakes, with a total area of 8,220km², are characteristics due to the topography, irregular rainfall and arid climate. Sebkhs are most common. These are inland depressions that fill with water in winter and dry in summer; salinity is generally high and variable. Lake Ichkeul (90km²) nature reserve is the most famous. Artificial lakes and dams are starting to grow; their present area is estimated at about 150km².

The internal renewable surface water is estimated as 3.100km³/year and renewable groundwater as 1.495km³/year. As overlap between surface water and groundwater is estimated to be 0.400km³/year, the total annual internal renewable resources would be 4.195km³. Exploitable fossil resources are estimated at 0.650km³. Including surface water and groundwater entering through Algeria, the total renewable water resources are 4.595km³.

About 2.100km³ of surface water resources are exploitable through reservoirs. It will be possible in future to increase this through significant work to conserve water and soil systems and groundwater recharge.

Renewable groundwater resources can be divided into two categories depending on the depth of the water:

- up to 50m, the waters are defined as tables and can be used for private enterprise, albeit with some restrictions (perimeters backup or prohibition). The potential is estimated at 0.745km³, but the volume actually used is 0.780km³/year – a 5 per cent rate of overexploitation;
- beyond 50m, deep groundwater is mainly reserved for public use. The potential is estimated at 1.400km³, including 0.650km³ from fossil aquifers in the south.

The total capacity of dams with a height of more than 15m is estimated at 2.555km³. The total exploitable resources of Tunisia, currently valued on an average basis, are of the order of 4.245km³. At present, the volume developed by large dams, hillside dams, lakes, boreholes and

shallow wells is estimated at 3.598km³, or about 85 per cent of total exploitable resources. The policy of creating large dams is associated with major developments in the fight against floods to protect cities and farmland.

The use of unconventional water resources has been considered over the past 30 years. The potential of treated wastewater, currently estimated at 0.148km³/year, is expected to reach 0.385km³ in 2020. Production of desalinated water from brackish groundwater resources in the south is estimated at present at 0.013km³/year, and is intended primarily to supply drinking water to urban centres in the southeast.

1.1.2. WATER USE

The total water withdrawal reaches 2.640km³/year, of which 2.165km³/year (82 per cent) is for irrigation. Groundwater constitutes 70 per cent of withdrawals, but is subject to overexploitation in some north-eastern and central regions. In the future, agricultural demands are set to continue to increase, while maintaining its dominance over other sector uses – irrigation accounts for 80 per cent, drinking water 16 per cent, and industry 4 per cent. A comprehensive programme of water saving irrigation has been carried out since 1995 to control agricultural water consumption and reduce irrigation requirements in the long term.

1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

Major environmental problems are health risks from ineffective disposal of toxic and hazardous waste; water pollution from raw sewage; limited natural fresh water resources; deforestation; overgrazing; soil erosion; desertification.

Irrigation waters are relatively salty (1.5-4g/L) but the degree of salinization of irrigated soils is not at unsafe levels because of leaching by irrigation water and rainfall. The latter, covering 23 per cent of the area managed, are subject to regular monitoring of salinity, particularly for land that can be affected by the raising of groundwater levels.

2. GOVERNANCE ASPECTS

2.1. WATER INSTITUTIONS

The Ministry of Agriculture, Environment and Water Resources (MAERH) is the leading operator in the field of water. Important Directorates General (DGs) in this department directly involved in water are:

- The Directorate General of Water Resources (DGRE), responsible for monitoring and evaluating water resources;
- Branch Dams and Major Water Works (DGBGTH), whose main activities are construction of dams and major water projects, and management of dams;

•The General Directorate of Agricultural Engineering and Water Exploitation (DGGREE), which is responsible for irrigation/drainage, rural infrastructure and water supply for rural people. The Agricultural Development (CRDA), which are attached to MAERH, are public administrative establishments with legal status and financial autonomy, charged with the regional development work of public irrigation schemes. The management of these schemes is shared between the CRDA and collective interest groups (CIGs). The CRDA, with support from the Agency for Extension and Agricultural Training (AVFA), are responsible for the dissemination of agricultural techniques and irrigation in the various irrigation schemes.

Other public institutions under the supervision of the department which are involved in the operations, planning and management of public schemes are SECADUNORD (operation and maintenance of large piped water transfer) and the Agricultural Land Agency (enforcement of land reform and monitoring of development).

Coordination of the water sector is provided by the Secretariat of State for Water Resources and Fisheries.

The National Agency of Environmental Protection (ANPE), under the supervision of Secretary of State for the Environment, is the government agency responsible for monitoring water quality and the fight against pollution.

2.2. WATER MANAGEMENT

The management of public irrigation schemes is provided directly by the CRDA for large schemes and user associations or CIGs for medium schemes. CRDA is responsible for operation and maintenance of irrigation systems, and the distribution of water to farmers for a fee paid by volume. Although operating costs and maintenance are generally collected for public irrigation schemes, the state continues to support the operations of major equipment replacement, and rehabilitation or modernization of irrigation systems.

In 2000, there were 966 CIGs whose objectives and functions included in particular the operation and maintenance of irrigation infrastructure available to them from the state, setting charges and distributing expenditure on water to meet the interests of each owner for development. Management associations are now spreading widely under management of the CRDA. Parallel to this operation, rehabilitation projects and modernization of public irrigation schemes are underway to facilitate network management by CIGs and create favourable conditions for the adoption of modern irrigation techniques.

2.3. WATER POLICY AND LEGAL FRAMEWORK

The Water Code, promulgated in 1975 (Act No. 75-61 of 31 March 1975, as amended and supplemented by Act No. 87-35 of 6 July 1987, No. 88-94 of 2 August 1988 and No. 2001-116 of 26 November 2001), constitutes the basic legislation governing intervention in the field of water. The main provisions of this code relating to agricultural use of water are particularly relevant to establishing the right to use, water conservation and the fight against waste, the requirement to recover agricultural water, the conditions for reuse of treated wastewater for agricultural

purposes, and methods of water pricing.

Land reform in public irrigation schemes is governed by Law No. 63-18 of 27 May 1963 (as amended and supplemented by Law No. 30 of 6 March 2000). This reform is based on four key principles:

- ownership restrictions by setting minimum and maximum sizes, according to the purpose of schemes;
- owners' contribution to the cost of water development;
- property consolidation to ensure rational use of water;
- development of managed lands.

3. GEOPOLITICAL ASPECTS

On 22 April 2009, Tunisia became the 17th nation to ratify the UN Convention on the Non-navigational Uses of International Watercourses. The convention represents the UN's effort to codify customary international law for transboundary freshwater resources.

The Watercourses Convention was designed to serve as a framework for more specific bilateral and regional agreements relating to the use, management and preservation of transboundary water resources. Additionally, it was intended to help prevent and resolve conflicts over international water resources, and to promote sustainable development and the protection of global water supplies.
